



A BILL FOR AN ORDINANCE

RELATING TO FEES AND PERMITS FOR BUILDING, ELECTRICAL, PLUMBING AND SIDEWALK CODES.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. The purpose of this ordinance is to encourage compliance with permitting requirements for building activities by strengthening sanctions against unpermitted building activities.

SECTION 2. Section 18-7.3, Revised Ordinances of Honolulu 1990 ("Criminal prosecution"), is amended by amending subsection (a) to read as follows:

"(a) General. Any person, firm or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and each such person shall be deemed guilty of a separate offense for each and every day or portion thereof during which any violation of the provisions of this chapter is committed, continued or permitted, and upon conviction of any such violation such person shall be punishable by a fine of not more than [\$1,000.00] \$2,000 or by imprisonment for not more than one year, or by both fine and imprisonment."

SECTION 3. Section 18-7.4, Revised Ordinances of Honolulu 1990 ("Administrative enforcement"), is amended by amending subsection (a) to read as follows:

"(a) Contents of the Order.

(1) The order may require the party responsible for the violation to do any or all of the following:

- (A) Correct the violation within the time specified in the order;
- (B) Pay a civil fine not to exceed [\$1,000.00] \$2,000 in the manner, at the place and before the date specified in the order;
- (C) Pay a civil fine not to exceed [\$1,000.00] \$2,000 per day for each day in which the violation persists, in the manner and at the time and place specified in the order.

(2) The order shall advise the party responsible for the violation that the order shall become final 30 calendar days after the date of its delivery. The

order shall also advise that the building official's action may be appealed to the building board of appeals.”

SECTION 4. Ordinance material to be repealed is bracketed. New material is underscored. When revising, compiling or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the brackets, the bracketed material or the underscoring.

SECTION 5. This ordinance shall take effect upon its approval and shall apply to violations that occur after the approval date of this ordinance.


