

RESOLUTION

RELATING TO THE ACCEPTANCE OF A GIFT OF ARTWORK FROM ROXANNE FAND TO THE CITY FOR THE ART IN CITY BUILDINGS COLLECTION OF THE CITY AND COUNTY OF HONOLULU MANAGED BY THE MAYOR'S OFFICE OF CULTURE AND THE ARTS.

WHEREAS, Roxanne Fand desires to gift a series of four paintings to the City and County of Honolulu; and

WHEREAS, the four paintings entitled: "Sunrise" completed in 2005, "Cosmic Variations" completed in 2006, "Cosmic Waves" completed in 2006, and "Cosmos 24" completed in 2006; are by Richard M. Fand; are from the artist's Cosmos Series; are acrylic on wood panel each measuring 23 inches by 23 inches; and

WHEREAS, Richard M. Fand, a painter and sculptor, was born in 1923 and passed away in 2006; studied art at: the Atelier Grande Chaumiere in Paris, France, Cornell University, New York, and the University of Hawaii where he was a also a professor of Mechanical Engineering from 1966 to 2003; and is the husband of Roxanne Fand; and was a member of the Association of Hawaii Artists; and

WHEREAS, Mr. Fand's works of art have been exhibited in Hawaii and internationally in such venues as the Honolulu Academy of Art, the Koa Gallery, the World Erotic Art Museum in Miami Beach, Florida, the Museum Erotica in Copenhagen, Denmark, and the Museo de la Erotica in Barcelona, Spain; and

WHEREAS, the Commission on Culture and the Arts approved to respectfully request the acceptance of this gift by the Council of the City and County of Honolulu on their meeting of July 8, 2010; and

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts given to City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated July 14, 2010, the Executive Director of the Mayor's Office of Culture and the Arts has submitted a request to the Council (and approved by the Managing Director) of the gift valued at \$3,600.00 for the Art in City Buildings collection; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now therefore,





An abstract painting of three tiered panels in gold, violet, and blue.



An abstract painting on tiered multi-levelled panels.


