



RESOLUTION

FILLING A VACANCY IN THE OFFICE OF COUNCILMEMBER FOR COUNCIL DISTRICT II.

WHEREAS, councilmember Donovan M. Dela Cruz was elected in November of 2006 to serve a four-year term from January 2, 2007 to January 2, 2011; and

WHEREAS, councilmember Dela Cruz has resigned from office in order to serve in the Hawaii State Senate; and

WHEREAS, as a result of councilmember Dela Cruz's resignation, a vacancy exists in the office of councilmember for Council District II, the unexpired term of which is less than one year; and

WHEREAS, Section 3-105 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition) ("revised charter") states in part that:

"A vacancy in the office of any councilmember shall be filled in the following manner:

(a) If the unexpired term is less than one year, the remaining members of the council shall elect a successor with requisite qualifications to fill the vacancy for the unexpired term. Vacancies shall be filled only at a regular meeting of the council after reasonable notice of intent to fill the vacancy has been given to all remaining members of the council by the presiding officer. Should the council fail to fill any vacancy within thirty days after its occurrence, the mayor shall appoint a successor to fill the vacancy for the unexpired term."

WHEREAS, Section 3-104 of the revised charter provides that in order to be eligible for election or appointment to the council, "a person must be a duly qualified elector of the council district from which the person seeks to be elected or appointed"; and

WHEREAS, the remaining members of the city council wish to fill the vacancy created by the resignation of councilmember Dela Cruz by electing someone to serve for the remainder of the unexpired term; and

WHEREAS, Reed Matsuura is a long-time resident of Council District II who has served on the staffs of three district councilmembers for over 13 years and is familiar with the issues facing the residents of the district; now, therefore,



RESOLUTION

BE IT RESOLVED by the Council of the City and County of Honolulu that it finds that Reed Matsuura is a duly qualified elector of Council District II and is hereby elected to fill the council vacancy for Council District II; and

BE IT FINALLY RESOLVED that Reed Matsuura shall serve for the remainder of councilmember Dela Cruz's term, which expires on January 2, 2011.


