

Carrie K. S. Okinaga

Carrie K. S. Okinaga is the Corporation Counsel of the City and County of Honolulu, appointed by Mayor Mufi Hannemann and most recently by Mayor Peter Carlisle. As Corporation Counsel, she is the chief in-house legal counsel for the City, with approximately 10,000 employees and an operating budget of \$1.8 billion. She supervises a department of 81 FTE positions, approximately half of which are attorneys practicing in diverse areas of law.

Ms. Okinaga was born and raised in Manoa Valley. She attended Manoa Elementary and graduated from Punahou School. After attending the University of Hawai'i at Manoa for one year, she transferred to Pomona College in Claremont, California, where she received her Bachelor of Arts Degree in Government/Public Policy in 1989. Ms. Okinaga graduated from Stanford Law School in 1992, and joined McCorrison Miller Mukai MacKinnon LLP, where she practiced for twelve years in the areas of litigation and employment law.
