



## RESOLUTION

RELATING TO THE NOMINATION OF SAMUEL E. H. MOKU AS DIRECTOR OF COMMUNITY SERVICES OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-301 of the Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes the department of community services which is headed by the director of community services; and

WHEREAS, Section 6-302, RCH, establishes the following powers, duties and functions of the director:

- (1) Develop and administer projects, programs and plans of action for human resources and human services programs;
- (2) Develop and administer projects, programs and plans of action designed to achieve sound community development, provided that such projects, programs and plans of action conform to and implement the general plan and development plans; and
- (3) Act as the local public officer for the purpose of implementing federally-aided and state-aided human resources, human services, urban renewal and community development programs;

and

WHEREAS, Section 4-104, RCH, requires that each department head be a registered voter of the City and County of Honolulu and that the mayor's nominees for department heads be confirmed by the council; and

WHEREAS, the mayor has nominated Samuel E. H. Moku as the director of community services through Mayor's Message 163 (2011); and

WHEREAS, after review of the nominee's experience, the council finds that Mr. Moku qualifies to serve as director of community services and merits confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Samuel E. H. Moku be confirmed as the director of community services of the City and County of Honolulu; and




