



A BILL FOR AN ORDINANCE

RELATING TO RENTAL FEES FOR THE MISSION MEMORIAL BUILDING COMPLEX.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. The Mission Memorial Building Complex consists of the three red-brick, Neo-Classical buildings located in the Honolulu Civic Center. In 1945, the city acquired the Mission Memorial Building Complex to ease congestion of office space in city hall. In 2003, the city decided to renovate the historic buildings and convert some of the office spaces back to its original state as an auditorium. In July 2004, the Mission Memorial Auditorium was reopened for use.

The purpose of this ordinance is to establish rental fees for the Mission Memorial Building Complex.

SECTION 2. The title of Chapter 28, Article 11, Revised Ordinances of Honolulu 1990, is amended to read as follows:

**“Article 11. Lease [and], Permit, and Rental Policy for the Grounds of City Hall, [and] the Honolulu Municipal Building, and the Mission Memorial Building Complex”**

SECTION 3. Chapter 28, Article 11, Revised Ordinances of Honolulu 1990, is amended by adding a new section to be appropriately designated by the revisor of ordinances and to read as follows:

**“Sec. 28-11. Rental fees for the Mission Memorial Building Complex.**

- (a) The department of budget and fiscal services is authorized to rent space at the Mission Memorial Building Complex and to set rental fees for the use of such space.
- (b) The director of budget and fiscal services shall adopt rules and regulation pursuant to HRS, Chapter 91, for the implementation, administration, and enforcement of this article.”

SECTION 4. Ordinance material to be repealed is bracketed. New material is underscored. When revising, compiling or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the brackets, the bracketed material or the underscoring.
