RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM SPORTS TURF HAWAII FOR THE ENHANCEMENT OF BASEBALL FIELDS AT VARIOUS CITY PARKS IN THE KAILUA AND KAI WAIMANALO COMPLEXES

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of the Department of Parks and Recreation has submitted a request for acceptance of a gift of fencing, irrigation parts, grass, cinder, and bases to the Council and approved by the Managing Director valued in the amount of \$11,761.18 from Sports Turf Hawaii to be used for the enhancement of baseball fields at various City parks in the Kailua and Kai Waimanalo Complexes; and

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$11,761.18 from Sports Turf Hawaii that is more fully described in the above-mentioned letter attached hereto from the Director of the Department of Parks and Recreation;






