**RESOLUTION**

WHEREAS, the Council finds that a sister city relationship with Caracas will be mutually beneficial, fostering opportunities for trade, market exploration, cultural exchange, and educational interaction between societies which have had little contact thus far; and

WHEREAS, the Council finds that such a relationship will be consistent with the policies of Resolution 91-240; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the Clerk is directed to extend the Council's invitation to the City of Caracas, Venezuela to establish a sister city relationship; and

BE IT FURTHER RESOLVED that, upon acceptance of this invitation by Caracas, the Mayor of the City and County of Honolulu is requested to prepare and enter into an agreement with the Alcalde of Caracas to formalize the sister city relationship; and

BE IT FURTHER RESOLVED that the agreement is requested to be consistent with the implementation policies of Resolution 91-240; and

## RESOLUTION

BE IT FINALLY RESOLVED that the Clerk is directed to transmit certified copies of this Resolution to the Alcalde of Caracas and Mayor of Honolulu.
