



RESOLUTION

RELATING TO THE APPOINTMENT OF LI BRADO COBIAN TO SERVE ON THE BOARD OF PARKS AND RECREATION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1404, Revised Charter of the City and County of Honolulu 1973, as amended (RCH), establishes an advisory Board of Parks and Recreation consisting of nine members appointed by the Mayor and confirmed by the Council to staggered five-year terms; and

WHEREAS, the major duties of the Board of Parks and Recreation are to advise the Mayor, the Council and the Director of the Department of Parks and Recreation on matters relating to the recreational, cultural and entertainment activities and facilities of the city and on the beautification of such facilities and public streets of the city; and

WHEREAS, by Mayor's Message 108 (2011), the Mayor has appointed Li Brado Cobian to the Board of Parks and Recreation; and

WHEREAS, if confirmed by the Council, Mr. Cobian will replace Ms. Joan Raines, who resigned, and serve the remainder of Ms. Raines' term which expires on December 31, 2013; and

WHEREAS, Section 13-103, RCH, which applies to the Board of Parks and Recreation, requires a member to be a registered voter of the city; and

WHEREAS, the Council has reviewed Mr. Cobian's qualifications and character and found that he is qualified to serve on the Board of Parks and Recreation and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the appointment of Li Brado Cobian to the Board of Parks and Recreation for a term expiring on December 31, 2013; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Cobian for his willingness to be considered for public service and actively participate in city government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, Board of Parks and Recreation, and Li Brado Cobian.




