### RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM THE HAWAII GARDENIA CIRCLE

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of the Department of Parks and Recreation, has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of a gift of cash in the amount of \$10,887.72 from the Hawaii Gardenia Circle for the upkeep of the Ala Wai Golf Course 2<sup>nd</sup> floor Multipurpose Facility; and,

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift (Exhibit A) attached hereto and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift of cash of \$10,887.72 from the Hawaii Gardenia Circle that is more fully described in the above-mentioned letter from the Director of the Department of Parks and Recreation; and




