"RESOLUTION RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM THE ASSOCIATION OF SKATEBOARDERS IN HAWAII,"

transmitted by Departmental Communication No. 781 from the Department of Parks and Recreation (DPR), dated December 16, 2011, reports as follows:

The purpose of this Resolution is to accept a gift from the Association of Skateboarders in Hawaii to the City for the DPR for skatepark improvements at Kailua District Park, valued at \$5,800.

Your Committee heard supportive testimony from the DPR Director.

Section 13-113 of the Revised Charter of the City and County of Honolulu 1973, as amended, provides as follows:

The Council, on behalf of the city, may accept gifts or donations of money, securities or other personal property or of real estate or any interest in real estate.

To implement this Charter provision, the Council adopted Resolution 05-349, CD1, FD1, which establishes guidelines for the solicitation and receipt of gifts on behalf of the City.
