



## RESOLUTION

RELATING TO THE APPOINTMENT OF PAMELA BELL MARTIN TO SERVE ON THE BOARD OF PARKS AND RECREATION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1404, Revised Charter of the City and County of Honolulu 1973, as amended (RCH), establishes an advisory Board of Parks and Recreation; and

WHEREAS, the Board of Parks and Recreation consists of nine members appointed by the Mayor and confirmed by the Council to staggered five-year terms; and

WHEREAS, the major duties of the Board of Parks and Recreation are to advise the Mayor, the Council and the Director of the Department of Parks and Recreation on matters relating to the recreational, cultural and entertainment activities and facilities of the City and on the beautification of such facilities and public streets of the City; and

WHEREAS, by Mayor's Message 3 (2012), as amended by Mayor's Message 8 (2012), the Mayor has appointed Pamela Bell Martin to the Board of Parks and Recreation; and

WHEREAS, if confirmed by the Council, Ms. Martin will succeed Mr. Wilbert Ching, whose term expired on December 31, 2006, and will serve for a term to expire on December 31, 2016; and

WHEREAS, Section 13-103, RCH, which applies to the Board of Parks and Recreation, includes a general qualification requiring a member to be a registered voter of the City; and

WHEREAS, the Council has reviewed Ms. Martin's qualifications and character; and

WHEREAS, based on the review, the Council finds that Ms. Martin qualifies to serve on the Board of Parks and Recreation and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the appointment of Pamela Bell Martin to the Board of Parks and Recreation for a term expiring on December 31, 2016; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Martin for her willingness to be considered for public service and actively participate in City government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, the Director of the Department of Parks and Recreation, the Board of Parks and Recreation, and Pamela Bell Martin.




