



RESOLUTION

RELATING TO THE TRANSFER OF FUNDS

WHEREAS, Section 2-17.2(c) (2), Revised Ordinances of Honolulu 1990, as amended, requires that the City Council approve by resolution any transfer of funds between characters of expenditure within the same activity whenever the cumulative amount of transfers from or to a character of expenditure exceeds the lesser of \$100,000 or the greater of ten percent of the appropriation for either the originating or receiving character of expenditure, or \$10,000; and

WHEREAS, a transfer not to exceed \$1,200,000 between the characters of expenditure is required by the Honolulu Emergency Services Department (HESD) to comply with a federal mandate requiring the transfer of all Emergency Medical Services (EMS) radio communications to the 800 megahertz radio system by January 1, 2013; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that an amount not to exceed \$1,200,000 in General Fund (GN) monies be transferred as needed between the following characters of expenditure:

Agency	From	To	Amount	Fund
HESD	EMS (S)	EMS (CE)	\$710,000	GN
HESD	EMS (E)	EMS (CE)	\$490,000	GN

And

BE IT FURTHER RESOLVED that the Mayor of the City and County of Honolulu or his designee is hereby authorized to carry out the provisions of this Resolution; and




