



A BILL FOR AN ORDINANCE

RELATING TO FEES FOR RECREATIONAL FACILITIES.

BE IT ORDAINED by the People of the City and County of Honolulu:


SECTION 1. The purpose of this ordinance is to clarify when fees are charged for use of certain city recreational facilities.

SECTION 2. Section 10-2.7, Revised Ordinances of Honolulu 1990, is amended to read as follows:

“Sec. 10-2.7 Fees for attendant/custodian services.

Organizations [whose use of city recreational facilities requires an attendant or custodian,] using city recreational facilities outside of the facility’s posted operational hours shall pay attendant/custodian service fees to the city of \$15.00 per hour for a custodian or an attendant. For the purposes of this section, “posted operational hours” means the hours a recreational facility is open for use by the public as posted on a sign or other notice conspicuously posted at the facility or on a city website. Fees collected pursuant to this subsection shall be deposited into a special fund, established by the mayor and approved by the council, or into a special account of the general fund for the use of the department of parks and recreation for expenses relating to park services. No fees shall be collected unless a special account or special fund is established.”

SECTION 3. Ordinance material to be repealed is bracketed. New material is underscored. When revising, compiling or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the brackets, the bracketed material or the underscoring.






