ACCEPTING A GIFT TO THE CITY TO PARTICIPATE IN THE "ASPEN SOCRATES PROGRAM" SEMINAR IN ASPEN, COLORADO.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu, as revised, provides the City Council with sole authority to accept gifts on behalf of the City; and

WHEREAS, in an email dated April 9, 2012, the Aspen Institute awarded the William D. Budinger scholarship to Councilmember Stanley Chang to participate in the Aspen Institute Socrates Program seminar from July 5-8, 2012, in Aspen, Colorado; and

WHEREAS, the scholarship will cover the costs for tuition, meals, lodging, and air transportation with a total value of about \$3,514; and

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift form attached as Exhibit A and incorporated herein; and

WHEREAS, the Aspen Institute Socrates Program is intended to provide a forum for emerging leaders from various professions to convene and explore contemporary issues through expert-moderated dialogue; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the Council hereby accepts a gift to the City from the Aspen Institute for the costs of tuition, meals, lodging, and air transportation for one City Councilmember (Councilmember Stanley Chang) to attend and participate in the "Aspen Institute Socrates Program" seminar to be held from July 5 to July 8, 2012 in Aspen, Colorado; and

BE IT FURTHER RESOLVED that the Council expresses its deep appreciation to the Aspen Institute for this generous gift to the City; and




