

WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of the Department of Parks and Recreation has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of a gift of cash in the amount of \$8,483.38 for McCoy Pavilion and \$8,483.38 for Ala Moana Regional Park maintenance from Shinnyo-en Hawaii; and

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift (Exhibit A), attached hereto and incorporated herein; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift of cash totaling \$16,966.76 from Shinnyo-en Hawaii that is more fully described in the above-mentioned letter from the Director of Parks and Recreation; and


