



## RESOLUTION

---

RELATING TO THE RE-APPOINTMENT OF ADAM C. WONG TO SERVE ON THE BOARD OF WATER SUPPLY OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 7-101, Revised Charter of the City and County of Honolulu 1973, as amended (RCH), establishes a Department of Water, to be known as the Board of Water Supply; and

WHEREAS, Section 7-104, RCH, creates a policy-making body consisting of seven members, two ex officio and five appointed by the Mayor and confirmed by the Council to five-year terms; and

WHEREAS, in general, the Board of Water Supply has the duty of developing, managing, controlling, and operating the City's water systems; and

WHEREAS, by Mayor's Message 77 (2012), the Mayor has re-appointed Adam C. Wong to the Board of Water Supply; and

WHEREAS, if confirmed by the Council, Mr. Wong will extend his membership beyond his first term, which expired on June 30, 2012, and will serve for a second term that will expire on June 30, 2017; and

WHEREAS, Section 13-103, RCH, which applies to the Board of Water Supply, includes a general qualification requiring a member to be a registered voter of the City; and

WHEREAS, after reviewing the nominee's qualifications, the Council finds that Mr. Wong qualifies to continue to serve on the Board of Water Supply and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the re-appointment of Adam C. Wong to the Board of Water Supply be confirmed for a term expiring on June 30, 2017; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Wong for his willingness to continue in public service and active participation in City government; and




