



RESOLUTION

RELATING TO THE APPOINTMENT OF CHERYL PALESH TO SERVE ON THE BUILDING BOARD OF APPEALS OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 16-1.1(13), Revised Ordinances of Honolulu 1990 ("ROH"), establishes the Building Board of Appeals ("Board") consisting of nine members who are appointed by the Mayor and confirmed by the Council to five-year terms; and

WHEREAS, Section 16-1.1(13), ROH, provides that the Board has the duties of hearing and determining the following:

- (1) Appeals of decisions regarding the administration of the Building Code, Electrical Code, Plumbing Code, Housing Code, Fire Code, Building Energy Efficiency Standards, and building permit ordinance;
- (2) Petitions for variances from the Building Code, Electrical Code, Plumbing Code, Fire Code, and Building Energy Efficiency Standards;
- (3) Appeals of decisions regarding the administrative enforcement of the litter control ordinance; and
- (4) Appeals concerning the summary removal of unlawful signs from street rights-of-way and public malls;

and

WHEREAS, by Mayor's Message 91 (2012), dated August 29, 2012, the Mayor has appointed Ms. Cheryl Palesh to the Board; and

WHEREAS, if confirmed by the Council, Ms. Palesh will replace Glen Arakaki, whose term expired on December 31, 2011, and will serve for a term to expire on December 31, 2016; and

WHEREAS, Section 16-1.1(13), ROH, establishes a general qualification requiring each member of the Board to be "qualified by experience and training to pass upon matters pertaining to building construction and fire safety"; and

WHEREAS, Section 16-1.1(13), ROH, further provides that of the nine members of the Board, "four members shall be currently licensed as engineers or architects with the State of Hawaii board of registration of professional engineers, architects, land surveyors, and landscape architects"; and

WHEREAS, Ms. Palesh is being appointed to be a member of the Board with experience and training in engineering or architecture; and

WHEREAS, Section 13-103(a), Revised Charter of the City and County of Honolulu 1973, as amended, which applies to the Board, requires a member to be a registered voter of the City; and

WHEREAS, the Council has reviewed Ms. Palesh's qualifications and finds that Ms. Palesh qualifies to serve on the Board and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the appointment of Cheryl Palesh to the Building Board of Appeals for a term to expire on December 31, 2016; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Palesh for her willingness to be considered for public service and actively participate in city government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, the Chair of the Building Board of Appeals, and Cheryl Palesh.




