WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Administrator of the Liquor Commission of the City and County of Honolulu has submitted a request for acceptance of a gift to the City of 500 2012 Drivers License Guide booklets, valued at \$1,600.00, to support new licensee orientation and liquor server/seller training; and

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift (Exhibit A) and incorporated herein; now, therefore,
