WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of the Department of Parks and Recreation, has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of a gift of cash in the amount of \$3,300 from the Hawaii United Okinawa Association for the upkeep of Kapiolani Regional Park; and

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift (Exhibit A) attached hereto and incorporated herein; now, therefore,






