



RESOLUTION

RELATING TO THE ACCEPTANCE OF GIFTS OF REAL PROPERTY TO THE CITY FROM THE JAMES CAMPBELL COMPANY LLC

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, the City currently leases 7.50 acres of property comprising a portion of Kahuku District Park and 4.35 acres of Puuloa Neighborhood Park from James Campbell Company LLC; and

WHEREAS, James Campbell Company LLC desires to gift the two properties to the City for use as parks open to the public; and

WHEREAS, through a letter, the Director of the Department of Parks and Recreation has submitted a request for acceptance of gifts to the Council and approved by the Managing Director of a gift of 7.50 acres of real property comprising a portion of Kahuku District Park and 4.35 acres of real property comprising the Puuloa Neighborhood Park from the James Campbell Company LLC; and

WHEREAS, the description and value of the gifts are set forth in the Declaration of Gift (Exhibit A), attached hereto and incorporated herein; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift of 7.50 acres of real property comprising a portion of Kahuku District Park valued at \$1,276,900.00 and 4.35 acres of real property comprising the Puuloa Neighborhood Park valued at \$297,000.00 from the James Campbell Company LLC., that is more fully described in the above-mentioned letter from the Director of the Department of Parks and Recreation; and

STATEMENT OF OWNERSHIP AND/OR TERMS OF CONVEYANCE	
<p>James Campbell Company LLC, a Delaware limited liability company ("Donor") has leased Puuloa Park (described below) to the City and County of Honolulu for public park purposes under a fifty-five (55) year lease, that commenced on August 1, 1961, and expires on July 31, 2016. Donor has also leased Kahuku District Park (described below) to the City and County of Honolulu for public park purposes under a fifty-five (55) year lease, that commenced on July 1, 1986, and expires on June 30, 2041. The City and County of Honolulu assesses real property taxes to Donor as the landowner, and thereafter reimburses Donor for such real property taxes under applicable terms and conditions of these long term leases.</p> <p>Donor desires to donate Puuloa Park and the Kahuku District Park to the City and County of Honolulu for the benefit of the communities in which these parks are located. As an additional benefit, donation of these parks to the City and County of Honolulu will reduce the expenses of operating Puuloa Park and Kahuku District Park because real property taxes will cease to accrue under City and County of Honolulu ownership.</p>
