## RESOLUTION

RELATING TO THE APPOINTMENT OF RICHARD JAN PETERSON TO SERVE ON THE CITIZENS ADVISORY COMMISSION ON CIVIL DEFENSE OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-104, Revised Charter of the City and County of Honolulu, 1973 ("RCH"), as amended, establishes a Citizens Advisory Commission on Civil Defense ("Commission") consisting of five members appointed by the Mayor and confirmed by the Council; and

WHEREAS, Section 6-104, RCH, provides that the primary duties of the Commission are advising the Mayor, the Council, and the civil defense administrator on matters pertaining to civil defense, and promoting community understanding and interest in such matters; and

WHEREAS, by Mayor's Message 126 (2012), the Mayor has appointed Richard Jan Peterson to the Commission; and

WHEREAS, if confirmed by the Council, Mr. Peterson will succeed Mr. Glenn T. Kimura, whose term expired on March 31, 2012, and serve a term ending on March 31, 2017; and

WHEREAS, Section 13-103, RCH, requires an appointee to the Commission be a registered voter of the City; and

WHEREAS, the Council has reviewed Mr. Peterson's qualifications and character and finds that he qualifies to serve on the Commission; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the appointment of Richard Jan Peterson to the Citizens Advisory Commission on Civil Defense for a term expiring on March 31, 2017 is hereby confirmed; and

BE IT FURTHER RESOLVED that the Council expresses its appreciation to Mr. Peterson for his commitment and willingness to actively participate in city government; and


