

Subject: Resolution Authorizing the Department of the Prosecuting Attorney to Transfer Funds

In accordance with Section 2-17.2, Revised Ordinances of Honolulu 1990, as amended, the Department of the Prosecuting Attorney requests your approval of the attached resolution authorizing the transfer of funds between characters of expenditures.

The requested resolution is needed to transfer \$600,000 in "Administration - Salaries" for Fiscal Year 2013 to "Prosecution - Salaries" for Fiscal Year 2013 in order to properly fund the restored 5% Base Salary Adjustment mandated by Mayor's Directive no. 11-3.

Please note that this is a resubmittal of our original September 24, 2012 hand delivered submittal. We were informed by the Managing Director's office that while our submittal was properly certified as "received in", the original paperwork and accompanying CD could not be located for further processing.

**RESOLUTION**

RELATING TO TRANSFER OF FUNDS

WHEREAS, Section 2-17.2 (c) (2), Revised Ordinances of Honolulu 1990, as amended, requires that the City Council approve by resolution any transfer of funds between characters of expenditure within the same activity whenever the cumulative amount of transfers between characters of expenditure exceeds the lesser of \$100,000 or ten percent of the appropriation for either the originating or receiving character of expenditure in the executive operating budget ordinance, provided that the ten percent portion exceeds \$10,000; and

WHEREAS, a transfer of \$600,000 between characters of expenditure is required to meet the program needs of the Department of the Prosecuting Attorney for the fiscal year 2013; and

WHEREAS, the amount being requested is necessary to properly fund the restored 5% Base Salary Adjustment mandated by Mayor's Directive no. 11-3; now therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that an amount not to exceed \$600,000 in General Fund monies be transferred between the following characters of expenditure:
