



## RESOLUTION

RELATING TO THE NOMINATION OF CLARKE LANCE KUHAUPI'O BRIGHT AS DIRECTOR OF THE ROYAL HAWAIIAN BAND OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 4-104 of the Revised Charter of the City and County of Honolulu 1973, as amended ("Charter"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the Council; and

WHEREAS, Section 6-105 of the Charter establishes the Royal Hawaiian Band, to be headed by the band director; and

WHEREAS, Section 2-15.1, Revised Ordinances of Honolulu 1990, as amended, charges the band director with the supervision, direction and control of the Royal Hawaiian Band, and with keeping an accurate inventory of band instruments, equipment, and fixtures; and

WHEREAS, Section 4-104.1 of the Charter requires that each department head be a registered voter of the City and County of Honolulu; and

WHEREAS, by Mayor's Message 3, dated January 2, 2013, the Mayor has nominated Clarke Lance Kuhaupi'o Bright to serve as Director of the Royal Hawaiian Band; and

WHEREAS, after review of the nominee, the Council finds that Mr. Bright qualifies to serve as band director and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Clarke Lance Kuhaupi'o Bright is confirmed as band director of the Royal Hawaiian Band of the City and County of Honolulu; and




