



**RESOLUTION**

RELATING TO THE TRANSFER OF FUNDS.

WHEREAS, Section 2-17.2(c)(1) Revised Ordinances of Honolulu 1990, as amended, requires that the City Council approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or ten percent of the amount appropriated for that activity in the executive operating budget ordinance, as may be amended, whichever is less; and

WHEREAS, a transfer not to exceed \$1,394,135 from the Provision for Salary Adjustment and Accrued Vacation Pay activity to the activities of the executive agencies is required for accrued vacation payments earned by former appointed employees and for certain groups of employees exempted from receiving supplemental time off in lieu of pay through supplemental union agreements; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that no more than \$1,286,596 in General Fund (GN); \$47,558 in Highway Fund (HW); \$17,405 in Sewer Fund (SW); and \$42,576 in Special Events Fund (SV) monies be transferred between the following activities and characters of expenditure:
