



RESOLUTION

APPROVING THE ABANDONMENT AND SALE OF THE THOMAS STREET ROAD STUB, PARCEL 1, ABUTTING TMK: 7-1-2:18, 7-4-10:14 and 88.

WHEREAS, Paragraph 16, Section 46-1.5, Hawaii Revised Statutes (HRS), as amended, authorizes the counties, under certain conditions, to dispose of real property as the interests of the inhabitants of the county may require; and

WHEREAS, Parcel 1 consisting of 1,407 square feet, is a portion of the Thomas Street road stub, as designated in Exhibit A, attached hereto and by reference made a part of this resolution; and

WHEREAS, Parcel 1 is a portion of a county highway as defined in Section 264-1, HRS, as amended; and

WHEREAS, Section 264-1, HRS provides that all county highways once established shall continue until vacated, closed, abandoned, or discontinued by a resolution of the legislative body of the county wherein the county highway lies; and

WHEREAS, Section 264-3, HRS provides that a county highway, before it is disposed of in any way, it shall be first offered to the abutters for a reasonable length of time and at a reasonable price; and

WHEREAS, the various City agencies, including the Departments of Facility Maintenance, Transportation Services, and Planning and Permitting, have no objections to the abandonment and sale of the Thomas Street road stub; and

WHEREAS, the Director of Budget and Fiscal Services ("BFS Director"), with the concurrence of the Corporation Counsel, has recommended to the Council to sell Parcel 1 pursuant to Sections 37-1.2, 37-1.4 and 37-1.6, Revised Ordinances of Honolulu, as amended; and

WHEREAS, by Resolution 12-48, dated March 21, 2012, the Council approved the sale of Parcel 1 to Mitchell Ken Komori, et al., the abutting property owners of TMK: 7-4-10:88, for the minimum sale price of \$8,000.00, based on an appraisal; and

WHEREAS, Mitchell Ken Komori, et al., subsequently decided not to purchase Parcel 1; and



RESOLUTION

WHEREAS, Kaala Estate, LLC the other abutting property of TMK: 7-1-2:18 and 7-4-10:14, who was originally not interested in purchasing Parcel 1, is now interested in acquiring Parcel 1; and

WHEREAS, the BFS Director has proposed and recommended the sale of Parcel 1, by negotiated sale to Kaala Estates, LLC for the minimum sale price of \$8,000 based on an appraisal; and

WHEREAS, the road stub will be sold subject to various easements for waterlines, manholes, access, and roadway purposes; and

WHEREAS, the recommended appraised sale price of \$8,000 will be deposited into the reserve for fiscal stability fund; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Parcel 1, being a portion of the Thomas Street road stub, as shown on said Exhibit A, is hereby abandoned as a public roadway effective as of the date of recordation of the deed of conveyance; and

BE IT FURTHER RESOLVED by the Council that it approves the sale of Parcel 1, the road stub located at Thomas Street, as shown on said Exhibit A, to Kaala Estates, LLC for the recommended sale price of \$8,000; and


BE IT FURTHER RESOLVED that the sale be in accordance with the recommendations of the BFS Director, and/or designee and with all applicable laws; and

BE IT FURTHER RESOLVED that the Council approves the recommended sale price received for the road stub in the total amount of \$8,000 be deposited into the reserve for fiscal stability fund; and

BE IT FURTHER RESOLVED that the BFS Director, and/or designee, shall be authorized to sign the deed and other necessary documents; and




