



RESOLUTION

RELATING TO THE APPOINTMENT OF STANLEY N. SATO TO THE ZONING BOARD OF APPEALS.

WHEREAS, Section 6-1516, Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes the Zoning Board of Appeals; and

WHEREAS, the Zoning Board of Appeals consists of five members appointed by the Mayor and confirmed by the Council to five-year terms; and

WHEREAS, the Zoning Board of Appeals has the duty of hearing and determining appeals from the actions of the Director of Planning and Permitting in the administration of zoning ordinances, zoning variances, and subdivision ordinances; and

WHEREAS, by Mayor's Message 47 (2013), the Mayor has appointed Stanley N. Sato to the Zoning Board of Appeals; and

WHEREAS, if confirmed by the Council, Mr. Sato will replace Antonio J. Saguibo, Jr., whose term was to expire on June 30, 2016, but which expiration was in error; the corrected new term for Mr. Sato is to expire on June 30, 2017; and

WHEREAS, Section 13-103, RCH, which applies to the Zoning Board of Appeals, includes a general qualification requiring a member to be a registered voter of the city; and

WHEREAS, the Council has reviewed Mr. Sato's qualifications and character; and

WHEREAS, based on the review, the Council finds that Mr. Sato qualifies to serve on the Zoning Board of Appeals and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the appointment of Stanley N. Sato to the Zoning Board of Appeals for a term expiring on June 30, 2017; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Sato for his willingness to be considered for public service and actively participate in city government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, the Chair of the Zoning Board of Appeals, and Stanley N. Sato.


