**RELATING TO THE TRANSFER OF FUNDS**

WHEREAS, Section 2-17.2(c)(1), Revised Ordinances of Honolulu 1990, as amended, requires that the City Council approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or ten percent of the amount appropriated for that activity in the executive operating budget ordinance, as may be amended, whichever is less; and

WHEREAS, a transfer not to exceed \$2,600,000 from the Provision for Energy Costs to the Department of Transportation Services (DTS) is required to fund salaries and wages incurred by Oahu Transit Services, Inc. related to the restoration of services in the fixed route bus system and the increased demand for service hours in the paratransit system in FY 2013; now, therefore,

BE IT RESOLVED by the Honolulu City Council that an amount not to exceed \$2,600,000 in the Provision for Energy Costs be transferred to the Department of Transportation Services;




