



## RESOLUTION

RECOMMENDING APPOINTEES TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

WHEREAS, Section 206E-3(a), Hawaii Revised Statutes ("HRS") establishes the Hawaii Community Development Authority ("Authority"); and

WHEREAS, the Authority is responsible for determining community development programs and cooperating with private enterprise and federal, state and county governments to bring plans to fruition in established community development districts; and

WHEREAS, on Oahu, the Authority currently exercises jurisdiction over the Kakaako Community Development District, the Kalaeloa Community Development District and the Heeia Community Development District; and

WHEREAS, Section 206E-3(b), HRS, establishes a board for each community development district headed by nine members; and

WHEREAS, three of the nine members of each board are "county members" appointed to 4-year terms by the Governor from a list provided by the local governing body; and

WHEREAS, Section 206E-3(b), HRS, further provides that when vacancies occur in any of the three county member positions of a board, the Governor shall fill such vacancies on the basis of one vacancy from a list of four recommendations, two vacancies from a list of seven recommendations, or three vacancies from a list of ten recommendations; and

WHEREAS, Section 206E-3(b), HRS, further provides that of the three county members of the Kakaako Community Development District, two shall be owners or active managers of a small business with its principal place of operation located within the community development district; and one shall be a resident of the community development district; and

WHEREAS, the Governor, by Miscellaneous Communication 860 (2013), has requested that the Council submit recommendations to fill the seat for Mr. Grady Chun, whose term on the board for the Kakaako Community Development District expired on April 25, 2013; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body recommends that the Governor consider the appointment of the following nominees as county members on the Authority's Kakaako Community Development District Board:
