



RESOLUTION

RELATING TO THE TRANSFER OF FUNDS

WHEREAS, Section 2-17.2 (c) (2), Revised Ordinances of Honolulu 1990, as amended, requires that the City Council approve by resolution any transfer of funds between character of expenditure within the same activity whenever the cumulative amount of transfer from or to a character of expenditure exceeds the lesser of \$100,000 or the greater of ten percent of the appropriation for either the originating or receiving character of expenditure, or \$10,000; and

WHEREAS, a transfer not to exceed \$1,450,000 between the characters of expenditure is required to meet the needs of the Emergency Medical Services (EMS) program of the Honolulu Emergency Services Department (HESD) for the fiscal year 2013; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that an amount not to exceed \$1,450,000 in General Fund (GN) monies be transferred as needed between the following characters of expenditure:

Agency	From	To	Amount	Fund
HESD	EMS (S)	EMS (CE)	\$850,000	GN
HESD	EMS (E)	EMS (CE)	\$600,000	GN

BE IT FURTHER RESOLVED that the Mayor of the City and County of Honolulu or his designee is hereby authorized to carry out the provisions of this Resolution; and




