





SUBJECT: Questions Relating To Non-Bid Contracts For Professional Service and the Synagro Contract for the Second Digester

The following is provided in response to the questions in your letter of February 14, 2013.

"(1) Please outline your department's non-bid selection process for professional services in accordance with Hawaii Revised Statutes (HRS) 103D-304;"

RESPONSE: All procurements for Professional Services are conducted in accordance with the procedures in Index Code 01.5, Professional Services, Budget and Fiscal Services Policies and Procedures Manual, which implements HRS 103D-304. An outline of the ENV Process for Professional Service Procurement is in Attachment A.

The "Long List" referred to in the ENV process is the list of qualified firms prepared by an approved Review Committee at the Department of Design and Construction (DDC) based on qualifications submitted to DDC in response to an annual advertisement for professional services.

"(2) Please provide any further legal and/or administrative requirements that are applied by your agency for non-bid contracts for professional services;"

RESPONSE: See Attachment A, ENV Process for Professional Service Procurement.

- "(3) For the last eight (8) years, by fiscal year, please provide:
- a. List of professionals that have been qualified through the HRS 103D-304 process;"

RESPONSE: DDC is providing the available "Long Lists" of qualified professional used during those years.

- "b. List of qualified professionals that have been selected for non-bid contracts and the amount of each contract as well as the cumulative amount per professional; and,"

RESPONSE: The list at Attachment B provides the qualified professional selected for non-bid contracts by the Department of Environmental Services by Fiscal Year. The list at Attachment C provides the summary of non-bid contracts by the Department of Environmental Services including the Vendor name, number of contracts, and the total amount of such contracts.

- "(4) Please reiterate your commitment and intent to ensure fairness and equitable distribution of non-bid contracts for professional services and how you intend to honor this commitment; and,"

RESPONSE: I am committed to fair and equitable distribution of non-bid contracts to responsible qualified professional service providers. I will honor this commitment by ensuring adherence to the requirements of HRS 103D-304 as implemented in the City by Budget and Fiscal Services Index Code 01.5. I will further remind ENV department staff of the need to follow such guidance as they participate in Selection Committees.

- "(5) For Environmental Services only, please provide the cost to the City for canceling the second digester project and for terminating the Synagro contract. Also, please provide a timeline for the planning, design and construction of the second digester.

RESPONSE:

1) *Canceling the second digester project:*

Planning/Design: Approximately \$1.2M in contracted work would be lost.

Construction: There would be no direct cost since the construction work has yet to be included in the contract.

Delay costs: Cancelling the project and proceeding with procurement to provide needed solids handling capabilities would involve contracting new planning and design work and the delay in construction would likely result in higher costs due to inflationary increases in construction costs. These costs, while not specifically determined, would be in the millions of dollars. In addition, delays do not resolve the issue of lack of redundancy and capacity in solids handling at Sand Island and leaves the City at considerable risk should the single digester fail. In the event of digester failure, it would be necessary to tanker raw sludge to other City treatment facilities and to take dewatered sludge to the landfill. Delays may also result in temporarily limiting development in the Sand Island basin.

2) *Terminating the Synagro contract:*

a) *The Synagro contract, Section 6.10, Termination for Convenience, provides for termination for convenience on the last day of the fifth full year of the contract term, which was September 30, 2012, or on the last day of the tenth full year of the contract term which will be September 30, 2017. To terminate the contract in accordance with Section 6.10 on the last day of the tenth full year of the contract term would require the City to provide written notice to Synagro at least 180 days prior to the last day of the tenth full year and to pay a \$1M, to be adjusted for inflation, early termination fee.*


b) *Synagro likely will initiate litigation for breach of contract if the City terminates the contract on any other date.*

- c) *The City would have to acquire and train additional staff to operate the existing digester and pelletizing facility. Operation of the sludge drying process is not something we currently have experience with and could require, at least on an interim basis, hiring another qualified private operator.*

- d) *Termination before the tenth full year would also impact or stop the ongoing Chemical Sludge Stabilization and Lift Station projects. Chemical Sludge Stabilization provides an alternative in the event of digester failure, while the Lift Station project is needed to resolve compliance issues related to the current discharge of the internal waste stream to a location not acceptable to the regulators.*

ATTACHMENT A

ENV Process for Professional Service Procurement

ENV submits a Request for Independent Services Contract via the M-4 eform.

M-4 defines the purpose, goal, and need for the professional service, the activities undertaken by Contractor, and the source of proposed funding.

M-4 is routed for review and approval through these departments: ENV Department Head, DIT (if \$25K or more IT-related purchase), BFS Fiscal, BFS Budget (if CIP funded), BFS Director, and Managing Director if CIP funded professional service.

Once M-4 is approved, ENV submits:

BFC11-04: Request for Approval of Review Committee (Used only for a separate solicitation, versus selection from DDC's pre-existing "Long List," which is prepared by an approved Review Committee at DDC.) – Recommended Review Committee members (minimum of three) are listed with their experience and qualifications. Committee members must have sufficient training, experience, credentials, and education related to the service category being evaluated. Committee members must be impartial and have no conflict of interest. Signed Affidavits/Attestation documents for all members are attached to the BFS11-04 form. The ENV Department Head or designee signs. Chief Procurement Officer approves.

BFC-11-06: Appointment of Selection Committee – Recommended Selection Committee members are listed with their experience and qualifications. Signed Affidavits/Attestation documents for all members are attached. Review and Selection Committee members attest to the following:

1. The committee member (CM) has no personal business, or any other relationship that will influence their decision in the applicable evaluation, review or selection process;
2. The CM agrees not to disclose any information on the applicable evaluation, review or selection process;
3. The CM agrees that their names will become public information upon award of the contract;
4. The CM has no personal or private interest or relationship that will cause a reasonable person, knowing all the facts, to question the person's impartiality;
5. If at any time the CM has an interest or relationship as in paragraphs 1 or 4, they shall (a) disclose it in writing to their appointing authority or to the Council (if the person signing the affidavit is employed at the Council) and to the Ethics

Commission as soon as the conflict becomes apparent, and (b) remove themselves from participating in the matter; and

6. Should the CM have any questions regarding potential conflicts of interest, they will contact the Ethics Commission at ethics@honolulu.gov or 768-7786.

The Evaluation Method is also identified. The Average Score, Individual Scoring Method is typically utilized. The ENV Department Head or designee signs. BFS Chief Procurement Officer approves.

Once approvals are obtained, ENV either:

If a separate solicitation, ENV provides information to Purchasing for a Request for Professional Services Qualifications (SOQ) solicitation. ENV describes the type of services required. ENV Review Committee reviews Statements of Qualifications submitted and provides list of qualified Contractors to the Selection Committee.

Selection Committee evaluates qualified Contractors from Review Committee (for separate solicitation) or from DDC's pre-existing "Long List".

The Selection Committee (SC) members evaluates the submittals of all qualified service providers listed by the Review Committee for the subject service category relative to the selection criteria identified in HRS 103D-304(e) and rank at a minimum the top three qualified service providers. The referenced selection criteria are as follows:

1. Experience and professional qualifications relevant to the project type,
2. Past performance on projects of similar scope for public agencies or private industry, including corrective actions and other responses to notices of deficiencies,
3. Capacity to accomplish the work in the required time, and
4. Any additional criteria determined in writing by the Selection Committee to be relevant to the project's needs or to be necessary and appropriate to ensure full, open, and fair competition for the professional service contract.

ENV submits a BFS-11-05: Approval of Selection and Delegation of Authority to Negotiate.

BFS-11-5 lists the three most qualified Contractors for the professional services required, as determined by the Selection Committee. Evaluation scores, committee member's comments, and ranking results are attached. ENV Selection Committee Chair signs. BFS Chief Procurement Officer approves.

Once BFS-11-05 is approved,

ENV enters negotiations with highest ranked Contractor and a requisition (RQS) is initiated by ENV in the City ERP system.

Scope of Work, Schedule of Work, Pricing, Special Provisions, and any required supporting documentation is attached to the RQS, which also indicates the M-4 number. The RQS package is routed for review and approval through ENV Division Chief, ENV CIP Head (if CIP funded), ENV Department Head (if over a certain amount), BFS Fiscal Accountant, BFS Fiscal Officer, and Purchasing.

Contract is drafted by Purchasing, based on a COR-approved template, and forwarded to ENV for review with the Contractor. ENV returns the edited contract back to Purchasing to be finalized and routed to the Contractor to be signed and notarized and then to the ENV Director, COR and the BFS Director to complete the signatures.

ENV issues Notice to Proceed to Contractor.
