



## RESOLUTION

WHEREAS, Section 14-102 of the Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes the Neighborhood Commission; and

WHEREAS, under Section 14-103, RCH, the Neighborhood Commission is responsible for developing the neighborhood plan, reviewing and evaluating the effectiveness of the plan and neighborhood boards, and assisting in the formation and operation of the neighborhood boards; and

WHEREAS, Section 14-105, RCH, establishes the position of Executive Secretary to the Neighborhood Commission to be filled by a person appointed by the Mayor and confirmed by the Council; and

WHEREAS, the Mayor has nominated Nicole A. Velasco as the Executive Secretary to the Neighborhood Commission through Mayor's Message 59 (2013); and

WHEREAS, after review of Ms. Velasco's qualifications and character, the Council finds that she qualifies to serve as the Executive Secretary and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Nicole A. Velasco be confirmed as Executive Secretary to the Neighborhood Commission; and




