WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City's executive agencies; and

WHEREAS, the policy provides for acceptance of gifts by affirmative action by the Council; and

WHEREAS, the Director of the Department of Parks and Recreation has submitted a request for acceptance by the Council of a gift of playground equipment, freestanding play, site furnishings and shipping valued at \$77,359.00 for Niu Valley Neighborhood Park from the Niu Valley Community Association; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift (Exhibit A) and incorporated herein; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$77,359.00 from the Niu Valley Community Association, that is more fully described in the above-mentioned letter from the Director of Parks and Recreation; and




