RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM THE MOANALUA VALLEY COMMUNITY ASSOCIATION, INC. FOR MOANALUA VALLEY NEIGHBORHOOD PARK

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution No. 05-349 CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of gifts by affirmative action by the Council; and

WHEREAS, the Director of the Department of Parks and Recreation has submitted a request for acceptance by the Council of a gift valued in the amount of \$11, 441.85 (Eleven Thousand Four Hundred Forty One Dollars and Eighty-Five Cents) for the refurbishing and restoration of the Gametime playground equipment at the Moanalua Valley Neighborhood Park; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift (Exhibit A) and incorporated herein; now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$11,441.85 (Eleven Thousand Four Hundred Forty One Dollars and Eighty-Five Cents) from the Moanalua Valley Community Association, Inc., that is more fully described in the above-mentioned letter from the Director of Parks and Recreation; and




