



RESOLUTION

RELATING TO THE IMMEDIATE ACCEPTANCE OF A GIFT TO THE CITY FOR THE MAYOR'S "HAWAII REMEMBERS SENATOR DANIEL K. INOUE" EVENT ON SEPTEMBER 7, 2013.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter from the Executive Director of the Mayor's Office of Culture and the Arts (MOCA), has submitted a request for immediate acceptance of a gift to the Council and approved by the Mayor of two (2) 2.5' X 10' customized full-color banners with grommets, valued at \$324.61 for the Mayor's "Hawaii Remembers Senator Daniel K. Inouye" event on September 7, 2013;

WHEREAS, MOCA is fully aware of and respects the guidelines for the solicitation and receipt of gifts to the City,

WHEREAS, this request comes under the unusual circumstances that the planning of the event was limited to less than one month and held between the monthly City Council meetings and therefore could not be brought before the City Council prior to the event, now therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift valued at \$324.61 from Arts & Signs LLC that is more fully described in the above-mentioned letter from the Executive Director of MOCA and the Declaration of Gift attached as Exhibit A; and




