



## RESOLUTION

---

RELATING TO THE APPOINTMENT OF CLAIRE E. GOLDBERG TO SERVE ON THE BOARD OF REVIEW II FOR REAL PROPERTY TAX APPEALS OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 8-12.6, Revised Ordinances of Honolulu 1990 (ROH), as amended, establishes boards of review for real property tax appeals under the Department of Budget and Fiscal Services; and

WHEREAS, each board consists of five members appointed by the Mayor and confirmed by the Council to five-year staggered terms; and

WHEREAS, Section 8-12.7, ROH, charges a board of review with the duty of hearing and deciding real property tax appeals; and

WHEREAS, by Mayor's Message 143 (2013), dated September 27, 2013, the Mayor has requested the Council approve Claire E. Goldberg's appointment to the Board of Review II; and

WHEREAS, if confirmed by the Council, Ms. Goldberg will replace Fely L. Faulkner, who transferred to the Board of Review I, and serve the remainder of Ms. Faulkner's term on the Board of Review II, which expires on June 30, 2015; and

WHEREAS, to qualify for service on the board of review, a member must comply with two requirements:

- (1) Section 8-12.6, ROH, requires a member to have resided in the State of Hawaii for at least three years at the time of the appointment; and
- (2) Section 13-103 of the Revised Charter of the City and County of Honolulu 1973, as amended, requires a member to be a registered voter;

and

WHEREAS, the Council has reviewed the qualifications and character of Ms. Goldberg and finds that she deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the appointment of Claire E. Goldberg to the Board of Review II for real property tax appeals for a term which expires on June 30, 2015 is hereby confirmed; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Goldberg for her willingness to be considered for public service and actively participate in city government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, Chair of Board of Review II, and Claire E. Goldberg.


