Your Committee on Executive Matters and Legal Affairs, to which was referred Bill 65 (2013) entitled:

"A BILL FOR AN ORDINANCE RELATING TO FINANCIAL DISCLOSURES,"

introduced on November 6, 2013 and which passed First Reading at the November 13, 2013 Council meeting, reports as follows:

The purpose of this Bill is to amend the City's financial disclosure requirements to align the City's disclosure requirements with the State's financial disclosure provision, Section 84-17(f)(5), Hawaii Revised Statutes, bringing the financial disclosures with the reporting requirements for public officials under Article XIV of the Hawaii State Constitution and recognize the legitimate privacy interests of City officers and employees.

Laurie Wong, Associate Legal Counsel, Ethics Commission, testified in support of Bill 65. Your committee received no written or oral testimony.


