



RESOLUTION

RELATING TO THE REAPPOINTMENT OF MARC C. TILKER TO SERVE ON THE POLICE COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1605, Revised Charter of the City and County of Honolulu, 1973 ("RCH"), as amended, establishes a Police Commission consisting of seven members appointed by the Mayor and confirmed by the Council; and

WHEREAS, the major duties of the Police Commission are:

- (1) Adopt such rules as it may consider necessary for the conduct of its business and review rules and regulations for the administration of the department;
- (2) Review the annual budget prepared by the Chief of Police and make recommendations to the Mayor;
- (3) Submit an annual report to the Mayor and the City Council;
- (4) Receive, consider and investigate charges brought by the public against the conduct of the department or any of its members and submit a written report of its findings to the Chief of Police;
- (5) Review and, if deemed necessary, make recommendations on the Police Chief's five-year plan and any update of the Chief's goals and objectives for the police department;
- (6) Compare at least annually the actual achievements of the police department against the goals and objectives of the five-year plan or latest update; and
- (7) Evaluate, at least annually, the performance of duties by the Chief of Police;

and

WHEREAS, by Mayor's Message 179 (2013), the Mayor has reappointed Marc C. Tilker to the Police Commission; and

WHEREAS, if confirmed by the Council, Mr. Tilker, whose initial term expired on December 31, 2013, will serve for a second term which expires on December 31, 2018; and



RESOLUTION

WHEREAS, Section 13-103, RCH, requires an appointee to the Police Commission to be a registered voter of the City; and

WHEREAS, the Council has reviewed Mr. Tilker's qualifications and character and finds that he qualifies to serve on the Police Commission; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the reappointment of Marc C. Tilker to the Police Commission for a term expiring on December 31, 2018 is hereby confirmed; and

BE IT FURTHER RESOLVED that the Council expresses its appreciation to Mr. Tilker for his commitment and willingness to actively participate in city government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, the Chief of Police, the Chair of the Police Commission and Marc C. Tilker.




