**AUTHORIZING THE MAYOR OF THE CITY AND COUNTY OF HONOLULU TO REQUEST THE GOVERNOR OF THE STATE OF HAWAII TO RELEASE FUNDS APPROPRIATED BY THE STATE LEGISLATURE FOR WAIPIO NEIGHBORHOOD PARK**

WHEREAS, Chapter 1, Article 8, Revised Ordinances of Honolulu 1990, states that any intergovernmental agreement or any amendment thereof, which places an obligation upon the City or any department or agency thereof, shall require prior City Council consent and approval; and

WHEREAS, Section 10 of Ordinance 13 - 20 (the executive capital budget ordinance for FY 2014) provides that limited purpose monies not specified in the ordinance are appropriated if approved by the Council; and

WHEREAS, the 2012 State Legislature appropriated \$25,000 in State general obligation bond funds to the City and County of Honolulu for a new batting cage at Waipio Neighborhood Park; and

WHEREAS, State general obligation bond funds will be used for the planning, design, construction, and equipment necessary for this project; and

WHEREAS, the project will provide the community with a new recreational resource; now, therefore,

**BE IT RESOLVED** by the Council of the City and County of Honolulu that the Mayor be and is hereby authorized to request the Governor of the State of Hawaii to release the \$25,000 general obligation bond funds appropriated by the Legislature for a new batting cage at the Waipio Neighborhood Park; and

**BE IT FURTHER RESOLVED** that the Mayor be authorized to execute all necessary agreements in furtherance thereof; and

**BE IT FURTHER RESOLVED** that the Mayor be authorized to accept and expend the funds for the purposes intended; and




