



RESOLUTION

REQUESTING THE CONSENT AND APPROVAL OF THE CITY COUNCIL TO INITIATE LEGAL ACTION AGAINST SHOSHANNAH WONG REGARDING DAMAGE TO CITY PROPERTY DUE TO MOTOR VEHICLE ACCIDENT ON JULY 10, 2012.

WHEREAS, the City owns property consisting of a bus shelter and bench located on Lumiaina Street in Waipahu; and

WHEREAS, on July 10, 2012, Shoshannah Wong, while operating a motor vehicle, damaged the City's bus shelter and bench located on Lumiaina Street; and

WHEREAS, the cost to repair the damage to the bus shelter and bench was \$4,612.00; and

WHEREAS, the filing of a lawsuit against Shoshannah Wong is necessary to resolve the issue of compensation to the City for the damage to the bus shelter and bench; and

WHEREAS, Section 2-3.2(b), Revised Ordinances of Honolulu 1990, as amended, requires that the Corporation Counsel obtain the consent and approval of the City Council before bringing legal action against private persons; now therefore,



RESOLUTION

BE IT RESOLVED by the Council of the City and County of Honolulu that:

Pursuant to Section 2-3.2(b), Revised Ordinances of Honolulu 1990, as amended, the Corporation Counsel is authorized to initiate legal action against Shoshannah Wong to seek damages and costs against Shoshannah Wong for damage to the City's bus shelter and bench located on Lumiaina Street, Waipahu as the result of a motor vehicle accident on July 10, 2012;

BE IT FINALLY RESOLVED by the Council that the Clerk be and hereby is directed to transmit copies of this Resolution to the Corporation Counsel.


