Your Committee on Parks and Customer Services, to which was referred Resolution 14-113 entitled:

"RESOLUTION RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM MALAMA PUPUKEA-WAIMEA,"

introduced on May 14, 2014, reports as follows:

The purpose of this Resolution is to accept a gift valued at \$50,000.00 from Malama Pupukea-Waimea for six interpretive/educational signs and installation costs for Pupukea and Waimea Beach Parks. Three custom interpretive/educational signs are relating to the Pupukea Marine Life Conservation District: Sharks Cove, Three Tables (Kalua Maua), and Waimea Bay. The other three interpretive/educational signs are relating to the Hawaiian Islands Humpback Whale National Marine Sanctuary.

The Director of the Department of Parks and Recreation testified in support of the Resolution and requested Council's favorable consideration.

Your Committee received written and oral testimony in support of the Resolution from Denise Antolini, President of the Malama Pupukea-Waimea Board of Directors.
