Your Committee on Parks and Customer Services, to which was referred Resolution 14-137 entitled:

"RESOLUTION RELATING TO THE APPOINTMENT OF ANTHONY J. SILVA TO SERVE ON THE COMMISSION ON CULTURE AND THE ARTS OF THE CITY AND COUNTY OF HONOLULU,"

introduced on June 10, 2014, pursuant to Communication MM-53, dated May 21, 2014 from Mayor Kirk Caldwell, reports as follows:

The purpose of this Resolution is to confirm Mayor Caldwell's appointment of Anthony J. Silva as the At-large member of the Commission on Culture and the Arts. Mr. Silva will succeed Roy Benham and serve for a term to expire on June 30, 2015.


