Your Committee on Budget, which considered Resolution 14-126 entitled:

"RESOLUTION RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM REGION IV, INC., AMERICAN ASSOCIATION OF MOTOR VEHICLE ADMINISTRATORS TO ATTEND THE 2014 REGION IV CONFERENCE IN VANCOUVER, BC, CANADA ON JUNE 2 THROUGH JUNE 6, 2014,"

introduced on June 3, 2014, reports as follows:

The purpose of the Resolution is to accept a gift to the City from Region IV, Inc., American Association of Motor Vehicle Administrators, valued at \$1,805, for airline tickets, lodging, meals and conference registration for the 2014 Region IV Conference in Vancouver, BC, Canada from June 2 through June 6, 2014.

A representative of the Department of Customer Service testified in support of the Resolution.

Section 13-113 of the Revised Charter of the City and County of Honolulu 1973, as amended, provides as follows:

The council, on behalf of the city, may accept gifts or donations of money, securities or other personal property or of real estate or any interest in real estate.
