Your Committee on Zoning and Planning, to which was referred
Resolution 14-139 entitled:

"RESOLUTION RELATING TO THE APPOINTMENT OF JASON C. TAKARA
TO SERVE ON THE BUILDING BOARD OF APPEALS OF THE CITY AND
COUNTY OF HONOLULU,"

introduced on June 17, 2014, reports as follows:

The purpose of Resolution 14-139 is to confirm the appointment of
Jason C. Takara as a member of the Building Board of Appeals. Mr. Takara, if
confirmed, will replace Kevin Katayama, whose term expired on December 31, 2002,
and will serve for a term to expire on December 31, 2017. Mr. Takara, a retired fire
captain, will serve as one of the two members of the Board who are required to be
qualified by experience and training to pass on matters pertaining to fire safety.

A public hearing on the appointment of Mr. Takara was held on June 4, 2014, at
a meeting of the City Council.

At your Committee's meeting on June 26, 2014, written testimony in support of
the Resolution was submitted by Robert Lee, Hawaii Fire Fighters Association. There
was no public testimony offered on the Resolution.
