Your Committee on Zoning and Planning, to which was referred  
Resolution 14-142 entitled:

“RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNATED  
REPRESENTATIVE TO ENTER INTO AN INTERGOVERNMENTAL  
AGREEMENT BETWEEN THE CITY AND COUNTY OF HONOLULU,  
DEPARTMENT OF PLANNING AND PERMITTING AND THE HAWAII  
COMMUNITY DEVELOPMENT AUTHORITY TO STUDY PUBLIC VIEWS FOR  
URBAN HONOLULU, AND TO IMPROVE THE THOMAS SQUARE-BLAISDELL  
CULTURE AND ARTS NEIGHBORHOOD,”

introduced on June 19, 2014, reports as follows:

The purpose of Resolution 14-142 is to authorize the Mayor, or the Mayor's designee, to execute an intergovernmental agreement with the Hawaii Community Development Authority (HCDA). The Memorandum of Agreement will provide the City with up to \$350,000 to employ a consultant to a) study and evaluate the policies on public views, heights, and density for urban Honolulu, including the Kakaako Community Development District; and b) to plan for and improve the Thomas Square-Blaisdell culture and arts district.


