

SUMMARY

David W. Rae has a long, distinguished career in land use planning and development, both locally and nationally. From working as a development consultant, to acting as a policy advisor to government, to his current role as Senior Vice President of Development at one of Hawai'i's largest private landowners, David has successfully worked on issues ranging from infrastructure and transportation plans, entitlements and zoning, environmental and economic impacts, and public affairs and issues management. To augment his professional expertise, David also has achieved extensive academic credentials with three masters degrees, including a Masters Degree in Urban and Regional Planning from the University of Hawai'i. David also has a long history of community involvement and support of Hawai'i's non-profit community including the Historic Hawai'i Foundation, the Neighborhood Justice Center, a founding member of the Kapolei Chamber of Commerce and past president of the Land Use Research Foundation
