1. **RESOLUTION 15-194 – INTERGOVERNMENTAL AGREEMENT (IGA) WITH STATE DEPARTMENT OF HEALTH TO IMPLEMENT A PROGRAM ON PARKING FOR PERSONS WITH DISABILITIES.** Authorizing the Mayor or his Designee to enter into an IGA between the City and County of Honolulu, Department of Customer Services, Division of Motor Vehicle, Licensing and Permits and the State of Hawaii, Department of Health, Disability and Communication Access Board to implement a program on parking for persons with disabilities. 2. **RESOLUTION 15-178 – TRAFFIC STUDY FOR NORTH SCHOOL STREET.** Requesting the Department of Transportation Services to conduct a traffic study and make recommendations to alleviate traffic congestion on North School Street between Houghtailing Street and the Likelike Highway.

3. **RESOLUTION 15-204 – TRAFFIC STUDY BETWEEN THE LILIHA/NUUANU TRANSPORTATION CORRIDORS.** Requesting the Department of Transportation Services to conduct a traffic study and make recommendations to alleviate traffic, speeding and pedestrian/bicyclist safety concerns within the Liliha/Nuuanu Transportation Corridors.

4. **BILL 52 (2015) – RESTRICTED PARKING ZONES.** Relating to Restricted parking zones. [Bill 52 (2015) passed first reading on 7/8/15]
