



A BILL FOR AN ORDINANCE

TO AMEND CHAPTER 21, REVISED ORDINANCES OF HONOLULU 1990, AS AMENDED (THE LAND USE ORDINANCE), RELATING TO THE WAIKIKI SPECIAL DISTRICT.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is to amend the Waikiki Special District zoning map to conform with amendments to Zoning Map No. 3 (Moiliili-Kaimuki, Ordinance 86-106) made by Bill 57 (2015).

SECTION 2. Exhibit 21-9.13, Revised Ordinances of Honolulu 1990 ("Waikiki Special District Zoning Precincts"), is amended by amending the Waikiki Special District Zoning Precinct boundaries as shown on the map marked "Attachment 1" and made a part hereof.





-  Zoning District Boundary




PORTION OF


