**A BILL FOR AN ORDINANCE**

TO REZONE LAND SITUATED AT WAIKIKI, OAHU, HAWAII.

BE IT ORDAINED by the People of the City and County of Honolulu.

SECTION 1. Zoning Map No. 3 (Moiliili-Kaimuki), Ordinance No. 86-106, is hereby amended as follows: Land situated in the Waikiki Special District, hereinafter described, is hereby rezoned from the Apartment Precinct to the Apartment Mixed Use Subprecinct, and from the Apartment Precinct to the Public Precinct. The boundaries and areas of said Apartment Mixed Use Subprecincts are described as shown on the map attached hereto, marked "Exhibit A" and made a part hereof, and further identified as Tax Map Keys: 2-6-024: 001, 003-004, 011, 012, 014, 016, 020-022, and 024. The boundaries and areas of said Public Precinct are described as shown on "Exhibit A" and further identified as Tax Map Keys 2-6-024: 017 and 019.




