- Exhibit D A proposed bill to allow counties to make short-term investments with similar authority as the State Director of Finance.

- Exhibit F A proposed bill to allow persons with disabilities the option to indicate their disability on their identification cards, such as the State of Hawaii identification card or driver's license.
- Exhibit G A proposed resolution requesting the Hawaii State Legislature to urge Hawaii's Congressional Delegation to propose and pass an amendment clarifying that corporations are not people with Constitutional rights and that unlimited campaign spending is not free speech.
